



IMPORTANT TAX INFORMATION

The Form 1099-DIV (or substitute form) you received from your financial advisor or brokerage firm may include income derived from U.S. Government and agency obligations. Because the qualifications for exclusion vary by state (some states have investment threshold requirements), please consult your tax advisor for details.
