**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On November 6, 2020, the Board of Trustees of iShares Trust has approved a 4 for 1 split for the fund for shareholders of record as of the close of business on December 2, 2020, payable after the close of trading on December 4, 2020.

**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ Under Internal Revenue Code (IRC) Section 305(a), the stock split was a non-taxable transaction. Under IRC Section 307(a), each shareholder is required to allocate the aggregate tax basis in his or her shares held immediately prior to the 4 for 1 split among the shares held immediately after the split. As a result, the number of shares held by each shareholder were multiplied by 4 and the basis in each share following the stock split was 1/4 of the basis immediately prior to the stock split.
