14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ **On October 14, 2016, the Board of Directors of iShares, Inc. has approved a 1 for 2 reverse split for the fund effective before trading on November 7, 2016.**

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ **Under Internal Revenue Code (IRC) Section 305(a), the reverse stock split was a non-taxable transaction. Under IRC Section 307(a), each shareholder is required to allocate the aggregate tax basis in his or her shares held immediately prior to the 1 for 2 reverse split among the shares held immediately after the reverse split. As a result, the number of shares held by each shareholder were divided by 2 and the basis in each share following the reverse stock split was 2 times of the basis immediately prior to the reverse stock split.**
